January 14, 2020

1. Executive Director, Margarita Holguin, welcomed all organizations and stated the introduction.

**2. 2021 Regional Plan: A Bold New Vision in 5 Big Moves**

Jane Clough spoke about California being a leader in bringing down emission footprint and revolutionizing the way transportation is thought of with 5 big moves. SANDAG has looked at where people live vs where people work to find what makes sense for the community. By grouping sections into categories, SANDAG is able to show plans through their 5 sections: Next OS- enabling technology, Flexible fleets- last mile options, Transit leap- alternatives to driving, Complete corridors- optimizing roadways, and Mobility hubs- activity centers and transit. <https://www.sandag.org/>

**3. Connecting Families Resource Center**

Cecilia Triana presented on their center coming together because of parents not knowing where to find resources and wanted to connect people to different agencies. Their passion is to connect families through their afterschool program in a few elementary schools. **4. Calfresh Program Changes**

Maribelle Gallegos and Darlene Beltran presented the Calfresh program changes. Since June of 2019, SSI recipients are now eligible and of the 21,000 apps that have applied, 17,000 have been approved. An Able-bodied adult without dependent will be required to meet 20 hours of employment per week and will only be able to receive 3 month of Cal fresh in 36 months if not meeting criteria or are not exempt. This will begin April 1, 2020. Public charge has broadened their scope to now include other programs such as Calwork and Medi-cal. It is currently stopped until injunction occurs and will not be backdated. [www.cwda.org](http://www.cwda.org)- type immigration tool kit.

**5. Census 2020 for Agencies**

Margarita Holguin encourages participants to complete their Census and express why it is so important. Why Census? It is set in the constitution since 1790 and the numbers decide which area receives more government funds based on the amount of people in that area. The Census occurs every 10 years. Last census 29% young latino children were not counted. The hard to reach populations include African American, non-traditional residents, English second language, Latino, young children to give examples. There are four methods of participation- Internet, phone, paper form, in person. March 12 begins the invitations online. Census day is April 1.
