2. **UPAC New Leaf Recover Center**

3. **San Diego Hunger Coalition: Breakfast in the Classroom**
Paloma Perez and Jaqueline Ibarra spoke about how the program offers support and free technical assistance supporting organizations and businesses in the food system.
